## a) Chipper Program Cost-Share

Sarah Jones explained the Chipper Program has 10 months left of funding through the current CALFIRE grant. George Alves presented the Chipper call detail spreadsheet explaining the increase of calls since 2016. There are more calls and larger sizes of jobs. Sarah Jones recommended increasing the cost-share rate to \$65.00 an hour for the landowners. George Alves read the list of validating factors.
