#### **New Business:**

#### a) Resolution 21-02

Sarah Jones presented the details of the NACD Urban Agriculture grant proposal. The grant total is \$50,000.00 with 25% match. Sarah suggested using her time as the match. # b) Revision to Placer County Coordinated Fuel Break Phase 1, Request for Proposal (RFP)

# c) Contract for "Professional Services to Support CALFIRE fuels reduction Project."

Sarah Jones explained this is a direct contract like the Sac Headquarters contract. The contract will continue work on the North Fork Shaded Fuel Break Project. Steve Jones recommends removing the Joint power of authority and SCRMC in the scope of work. Tom Wehri moved to approve the Contract with the modifications. ## d) Professional Services Contract 21-004

Sarah Jones announced the District will not move forward with the current Bookkeepers contract. Sarah recommends the District enters in a contract with a CPA. Patti Beard moved to approve PSC21-004 for the new bookkeeper. Steve Jones seconded, and the motion passed unanimously.
